## 8. PERSONNEL ADMINISTRATION

8.5 Ratification of Tentative Agreement between the Desert Area Teachers Association (DATA) and the Board of Education Regarding Settlement of Contract Issues for 2014-15

BACKGROUND INFORMATION: The DATA and district negotiation teams reached a tentative agreement for 2014-15.

CURRENT CONSIDERATIONS: DATA and the district reached a tentative agreement regarding contract language changes and proposals. The most prominent feature of the tentative agreement is the proposed 2015-2016 pilot collaboration schedule (under Article VI Work Hours), which results in a 30 -minute late student start on Wednesdays. Another notable change under the same article is the provision that secondary teachers may choose to substitute on their prep period and either earn the substitute hourly rate of pay, or compensatory time. A signed tentative agreement, which outlines all changes, are included in the Board packet.

FINANCIAL IMPLICATIONS: Minimal costs may be incurred by the changes in the tentative agreement. The potential for a slight increase in substitute costs may be incurred with the change from two (2) to three (3) confidential leave days; and the change from $\$ 2$ to $\$ 3$ per day, per student for overages on speech therapist caseloads may result in a very minor increase to district cost.

SUPERINTENDENT'S RECOMMENDATION: Ratify the tentative agreement between the Desert Area Teachers Association (DATA) and the Board of Education regarding contract issues for 2014-15 as presented.

# TENTATIVE AGREEMENT <br> BETWEEN <br> SIERRA SANDS UNIFIED SCHOOL DISTRICT <br> AND <br> DESERT AREA TEACHERS ASSOCIATION 

The Desert Area Teachers Association and Sierra Sands Unified School District have reached a tentative agreement for 2014-15. The following terms and conditions reflect the tentative agreement of the Sierra Sands Unified School District and Desert Area Teachers Association:

1) The parties agree to revise Article VI Work Hours, section A. as follows: "A unit member shall be on duty according to the table presented in the pilot collaboration schedule 2015-2016."
C.1. is revised as follows: "Each site principal shall distribute an adjunct duty list. The list will describe each adjunct duty and estimate the number of hours required for the performance of that duty. Within one week of receiving the list, each unit member will request adjunct duties adding up to no more than 14-17 hours, not to exceed 18 hours, and will forward this 'wish list' to the school site principal. Unit members may agree to volunteer for adjunct duties beyond the maximum amount required."

In (D.) the third sentence will end with the following language: "(reduced to two (2) during the pilot collaboration schedule 2015-2016)."

In (E.) the third sentence will end with the following language: "( E is in abeyance during the pilot collaboration schedule 2015-2016)."

Changed (I.) with the following language: "Minimum days shall be provided at the elementary level as follows: Five (5) days at the end of first trimester for parent conferences, four (4) days at the end of the second trimester for parent conferences, and the last four (4) days of the school year."

Changed (K.) with the following language: "Period substitutions may be offered assigned during a teacher's preparation period. Teachers who accept those assignments may select either compensatory time off or pay at the substitute hourly rate. Those who choose the time off shall earn a credit of one hour for each period of substitution."

1. When five hours of credit are accumulated, the teacher shall be awarded a day off work without loss of pay on three days' advance notice. Days off pursuant to this paragraph shall not be granted if the day off would impact the operations of the school, SBAC testing, or final examination days.
2. Days off pursuant to this provision shall not be used to extend any holiday period.
3. An employee who completes the work year with hours of credit shall be compensated at the substitute rate.
4. Compensatory time must be used with a minimum two-hour block."

In (O.) started a new paragraph titled \#3. beginning with the sentence: "Each kindergarten or TK teacher shall meet..."

In (R.) a collaboration pilot table was added for 2015-16. It is attached to this agreement.
2) The parties agree to add the following language change: Article VII Class Size: (G.) after the words "fifty-five (55), "added "and their case load overages at all grade levels shall be paid at a rate of three dollars (\$3) per day per student, except students designated as "watch and consult." Also, in the second sentence, "and their" after the following words "(28) students."
3) The parties agree to add the following language change: Article VIII Leave Provisions: Under (A.) 7. "registered domestic partner." Under (B.) add \#6. "Sick leave may be used as prescribed under AB 1522 Healthy Workplaces, Healthy Families Act of 2014.
(1) Diagnosis, care, or treatment of an existing health condition of, or preventive care for, an employee or an employee's family member.
(2) For an employee who is a victim of domestic violence, sexual assault, or stalking."

Under (C.) 1. Change "two (2)" to "three (3)".
Under (K.) add the following language to the end of the first paragraph: "The unpaid family leave described in this paragraph is adopted pursuant to the Family Medical Leave Act and the California Family Right Act." Also under (K.) 4. b. parties agree to change language to "is equal to that of which each individual is entitled."

Instruction on collaboration day begins 30 minutes after the regular start of instruction. Staff meetings will be reduced to 2 hours per month. Grade-level meetings will be in abeyance during the pilot year.

Collaboration time shall be defined as time when teachers regularly meet to work in groups to improve student learning. Administration and bargaining unit members will mutually develop an agenda within the collaboration model. Collaboration shall be used to enhance effectiveness of instructional practices by focusing on student progress; to engage in dialogue relating to curriculum and instructional standards; to articulate and implement pacing plans; to use results of assessment to guide instruction; to determine student progress towards common assessments; to establish interventions; to share knowledge of subject matter content and best teaching strategies; and to apply materials, resources, and technologies to make subject matter accessible to students. Collaboration time will not be used for regular staff meetings, District meetings, or individual teacher classroom preparation time.
